One student had convulsions and the other two students became pale and passive. Madison High School reported that this is the second recent incidence involving synthetic marijuana.		
Pill Crusher Event Update	Robby Holland updated the task force members on the Pill Crusher Event. Mr. Holland said the event was held over three days in Highlands and around 11,000 pills were collected. He stated that in Franklin the event was only held on one day (March 26 th) and collected around 58,000 pills.		
	The task force members were very pleased with the number of pills collected, but stated that they would still like to have a permanent year-end collection location. The task force members said several towns around us (Clayton, Waynesville and Asheville) did have a permanent collection location.		
	The task force members agreed to continue discussing this topic and be open for any opportunities to make this happen.		
Update Middle School Project	Marci Holland passed around the top five designs for the flyer and the task force members voted on them. Ms. Holland stated that she would take the designs back to Ms. Mahler and give her the results of our vote.
