Other Items for Discussion	 Other Items for Discussion: CARENET Funds – Kathy McGaha (reporting for Vanessa Bailey) updated the committee members on CARENET and it current fund balance. Ms. McGaha said that current funds are covering the cost of food only. There are no extra funds available to cover emergency situations like housing, electricity, etc. Ms. McGaha said several factors (unemployment, foreclosures and increase in backpack program needs) play into this. Clean Slate Coalition – Kristi Case reported that the Clean Slate Coalition in Jackson County is now accepting applications for women needing transitional housing.
