Call to Order: Jerry Hermanson called the meeting to order at 6:17 p.m.

Welcome/Intro/ Departures/ Recognition/ Kathy McGaha announced the new MCPH Physician Allison Smith. There will be a meet and greet to welcome Allison before the next board meeting.

Announcements: Jerry Hermanson asked if there was Public Comment.

Public Comment:

Jessica Stanley, Keller Williams Realty and former county employee spoke first. She acknowledged the work of Environmental Health Department. Ms. Stanley expressed her respect for the staff, while stating they (realtors) have a job to do in which they give good service and expect good service in return. She ended by thanking the Environmental Health staff.

Evelyn Owens, Keller Williams Realty said she works with mostly sellers. She explained realtors are required to have a septic permit when a home is listed. She spoke about confusion of where to email for a septic permit. She added, when she has come in to the Environmental Health Department, Lynn Jenkins is excellent, very helpful, very kind. She acknowledged Macon County sells a lot more land than surrounding counties. Ms. Owens asked for better communication, for example; inform the Board of Realtors of which email to use and an estimated time to receive the permit. She added, sometimes the permits are received after the house is already under contract.

Jerry Hermanson asked if obtaining the septic permit before listing the property was a Board of Realtor requirement. Ms. Owens answered it is a Real-Estate Commission requirement. If a permit has not been issued, they need a statement saying there is not one.

Sheila Myers, Keller Williams Realty stated she had been a realtor for 24 years, 20 of those years in Macon County. She explained the realtors have to have the buyers and/or sellers obtain septic permits. She added that in the past year requirements for septic systems seem to have changed. They now have to designate where the septic will go on the property. She understands showing the house on the site plan and marking the corners of the survey. She says now they are also required to clear and mark the area where the septic is to go along with the location of the well. She feels the experts (Environmental Health) should determine the septic placement. Owners/buyers would not know that information. Ms. Myers said all of the sites now require pits. She explained one of her agents was told the Environmental Health Specialists only have 5 minutes to look at a lot as they are in a hurry and short staffed. She spoke on time wasted (sometimes several weeks) because of poor communication and emphasized the burden it places on the applicants. She mentioned other counties do not seem to have as many rules as Macon County.

Mr. Hermanson asked if there was a point of contact at the Health Department that can answer questions. Ms. Myers replied, yes and said she was told they are digging more pits because of liability. A local company will dig pits and help get the septic permit. However, they are 8 weeks out and of course there is an additional fee. She understands the Environmental Health people are working hard, but the process is certainly a burden.

Mr. Hermanson thanked the realtors for speaking about their experiences and acknowledged communications need to improve with the Board of Realtors. Ms. Myers added she was unaware of the change in requirements to show the septic location on the site plan and the difficulty of not knowing where it should go. Mr. Hermanson asked if this was regarding a new house. Ms. Myers answered yes this is for selling blank lot. They have to get a septic permit to make sure it perks before the sale. Therefore, there is a timeline involved too. She did note, that if Environmental Health knows there is a due diligence period, they will make sure it is done before that date. Adding, that she had a client drive from two hours away to take pictures of his lot showing it has been prepared before Environmental Health people will look at it.

Kathy McGaha, addressed Ms. Myers stating all of this is done in an effort to have the lot as prepared as necessary. Ms. McGaha stated these requirements are not just required locally. These are state requirements to have the site prepared so that when work has begun a permit is issued as accurately and as fast as possible. Determinations are soil dependent and they use best judgment and expertise when deciding if pits are needed. She added there are some counties across the state that require pits on every application. There has been discussion of Macon County having those same requirements, but that is an expense that may not be necessary.

Ms. Owens asked if there was another way of checking the soil without digging pits. Ms. McGaha answered, they use augers when the go out and make decisions about the soil based on training and expertise.

Ms. Myers asked if marking where the septic goes is a change coming from the state. Ms. McGaha replied that has always been a requirement. She added the struggle of not having sites ready has been discussed at Board of Health meetings. Having the site prepared is now a state required rule and an application cannot be accepted if the site is not prepared. Showing the proposed septic area on the site plan is an estimate and Environmental Health tries to put it in that area based on their findings in the soil. If they cannot put it in the area, they will contact the buyer to discuss adjusting the placement.

Mr. Hermanson recapped, saying it sounds like Environmental Health needs to do a better job communicating with the realtor community.

Paul Higdon added the Environmental Health Department is currently understaffed. He said he did not understand why they are understaffed and the surrounding counties are not. Ms. McGaha corrected Mr. Higdon, stating they are fully staffed. However, we have several in training. The last position will be filled on January 29th.

Paul Higdon said he appreciated the public coming to the meeting and sharing their concerns. He acknowledged the county is aware of issues. Nevertheless, he is appreciative of the staff. He stated there should be a team effort to improve channels of communication. Mr. Higdon also asked Ms. McGaha for an update on the Environmental Health Supervisor position. Ms. McGaha answered it is posted right now for the second time. Jessica Baucum added we have received 3 applications, 2 of which do not qualify. Ms. Baucum said getting qualified candidates has been a struggle.

Jerry Hermanson asked the group of realtors, who is the Executive Director of the Board of Realtors. Ms. Owens replied, Darlene Brabson.

Paul Higdon asked if any of the Environmental Health staff would like to make a comment. Chaz Allen commented about pits being required. He said there is always an auger boring performed on site. If the mineral saprolite is encountered at a certain depth, state law requires pits.

Ms. McGaha commented that there is a possibility an application for 100 tiny homes would be received within the next week. She posed the question "How do we respond to that? We can't turn them away." She emphasized the time and staff that would require. Paul Higdon asked what could be done to relieve the pressure of the current staff. He mentioned the previous use of contract labor and asked if it is still an option. Ms. McGaha replied if the funding was available, yes. Adding, we can always post more positions but have to pay them enough so they will stay and not go to another county. She gave the example of two recent employees who went to work for other counties for higher pay.

Ellen Shope asked Ms. McGaha how many permits were issued last year. Jeremy Pless from Environmental Health, answered. He said, in total the department had issued 1,334 documents. Ms. McGaha added that is a mixture of things, but still a lot of work. Not only is that a lot of work being done, but they are training staff at the same time.

Paul Higdon mentioned realtors need permits already issued for existing systems when selling property. He assumed IT had been working to make those available to the public. Ms. McGaha explained that County Attorney Eric Ridenour put a halt to that project. The application contains private information. A company will need to be hired to extract permits from the application files. She added we do not have the staff available to take on that project. Several realtors said it would be helpful to have this information before they list the property. The number of bedrooms on the permit is what has to go in the real estate listing. County Manager, Derek Roland said a proposal should be prepared and presented to the county commissioners for consideration.

Mr. Jonathan Fouts made the comment; he had been training 8 out of the 10 years he had been working for Macon County.

Ellen Shope asked if Macon County had a competitive pay scale compared to surrounding counties. Mr. Roland said since conducting a pay study and implementing it in 2020-2021, we

have been able to implement back-to-back 4.5% cost of living adjustments and step increases. In addition to that, through December of 2024, we are able to use American Rescue Funding to gain an additional \$2 per hour. He feels as though Macon County is competitive as it has ever been. He added that when you look at this issue it is not central to Macon County. When you look at other counties, even metropolitan areas, this is such a big issue. The need for Environmental Specialists is actually a state issue. It was the number one priority set by the North Carolina Association of County Commissioners to be addressed by the legislature. It was not addressed in the last budget cycle, but it will continue to be top priority for the NCACC. That group consists of all 100 counties in North Carolina and advocates on behalf of all counties. It says a lot that NCACC has made this issue a priority and is a statewide issue. Adding that, the Environmental Specialist position is in direct competition with the private sector. Pointing out that no matter how competitive we can be with the public sector, private sector can always go a notch above. All of these points create the perfect storm. Mr. Roland commended the Environmental Health staff the work that they do.

Ms. McGaha, asked if there is opportunity to give increases based on obtaining authorization or certifications since the positions require so much training. Mr. Roland replied that operationally our employees are our most valuable asset. He will advocate for employees each chance he gets, but acknowledged we have to work within the budget.

Paul Higdon asked if contract work benefited Macon County. Mr. Fouts answered saying it is a double-edged sword. He added they do help however; they are not used to our computer programs so they have to hand draw. They work on Saturdays, which makes communication difficult and depending on the quality of work, our people (Macon County Environmental Health) have to revisit a property. Ms. McGaha added that MCPH does not currently have an overtime budget. If the Environmental Staff wanted to work overtime, she could not pay them at this time.

Paul Higdon encouraged Ms. McGaha to present ideas to the Board of County Commissioners to address the issues identified after tonight's discussion. Mr. Roland agreed that this is the appropriate time with budget coming up.

Mr. Hermanson addressed the realtors. He gave assurance their concerns were heard and steps would be taken to improve various things. Communication should improve immediately. He thanked the realtors for their time and attendance.

Paul Higdon informed the group he would like to form a committee to discuss Environmental Health fees at another time.

Agenda Approval:

Ellen Shope made a motion to approve the agenda with the following changes: Remove Presentation Item A. MCPH Consumer Satisfaction Survey 2023 and move New Business Item B to the first agenda item. Paul Higdon seconded the motion. Motion passed unanimously.

Ms.McGaha noted Macon County fees are similar to surrounding counties. She asked the board members to review this information at home.

Garrett Higdon asked Ms. McGaha where the money goes that is collected for fees. Ms. McGaha replied, to the general fund. She added the only state required fee is \$35 for the Engineered Option/AOWE Permit. If fees are reduced, money will have to come from taxpayers. The fees are in place to offset some of the cost of services. Mr. Hermanson asked for the difference in what is collected versus the cost of providing the services. Ms. McGaha said Melissa Setzer, Finance Director would have that information later in the meeting when she presented the Mid-Year Budget Review. He asked if the fees covered expenses. Ms. McGaha replied, no. Mr. Hermanson asked if it was realistic to raise the current fees. Ms. McGaha answered that Paul Higdon would actually like to lower the fees. Paul Higdon explained he felt these are such valuable services to Macon County and noted the economic impact. Real estate, housing and construction dies if this service is not provided. Adding that if permits are issued quicker, we will receive a net income later on as opposed to collecting it on the front end. Ms. McGaha asked Paul Higdon if he would be looking at adjusting building permit fees as well. Mr. Higdon said he had not been questioned on building fees and did not know what their fee structure is. Adding he is not worried, our county has revenues available and he would like to keep this

program as efficient as possible and keep permits rolling out. Ms. McGaha let the board know she would answer any questions about the fee schedule.

Garrett Higdon asked what the main goal would be in reviewing the fees. Paul Higdon said there are a couple of fees that should be decreased. He gave the example: \$1000 for a 4-bedroom septic permit. Noting that it does not take much more work to lay out a 4-bedroom than a 3-bedroom system. Jeremy Pless interjected; he had determined a 4-bedroom to cost \$850. Ms. McGaha clarified the Environmental Health Department had been working on fee proposals. She mentioned the current tattoo permit fee. Lisa Browning said per tattoo artist is \$700 yearly and anyone working under that artist is an additional \$500 yearly. She noted the increase of artists from 1-2 and now total 19-20. Some artists work at multiple locations. The permit does not go with the artist it goes with the location. Paul Higdon agreed the fee is excessive. Ms. McGaha said all recommendations would be presented at the next meeting. Garrett Higdon recognized some of Macon Counties fees may be higher but the standard that Macon County requires is also higher.

Respiratory Disease Update

Jennifer Garrett presented the 2023-2024 Respiratory Season Report. See below.

Influenza Vaccine: A couple of things were different for the 2023-2024 influenza (flu) season:

 The <u>composition of flu vaccines</u> has been updated. Flu vaccines for the U.S. 2023-2024 season will contain the following:

Egg-based vaccines

- an A/Victoria/4897/2022 (H1N1)pdm09-like virus; (Updated)
- an A/Darwin/9/2021 (H3N2)-like virus;
- a B/Austria/1359417/2021 (B/Victoria lineage)-like virus; and
- a B/Phuket/3073/2013 (B/Yamagata lineage)-like virus.
- Cell- or recombinant-based vaccines
 - an A/Wisconsin/67/2022 (H1N1)pdm09-like virus; (Updated)
 - an A/Darwin/6/2021 (H3N2)-like virus;
 - a B/Austria/1359417/2021 (B/Victoria lineage)-like virus; and
 - a B/Phuket/3073/2013 (B/Yamagata lineage)-like virus.
 - These recommendations include one update compared to the 2022-2023 U.S. flu vaccine composition. The influenza A(H1N1)pdm09 vaccine virus component was updated for egg-based and cell- or recombinant-based flu vaccines.
- People with egg allergy may get any vaccine (egg-based or non-egg-based) that is otherwise appropriate for
 their age and health status. Previously, it was recommended that people with severe allergy to egg (those who
 have had any symptom other than hives with egg exposure) be vaccinated in an inpatient or outpatient medical
 setting. Beginning with the 2023-2024 season, additional safety measures are no longer recommended for flu
 vaccination of people with an egg allergy beyond those recommended for receipt of any vaccine, regardless of
 the severity of previous reaction to egg. All vaccines should be given in settings where allergic reactions can be
 recognized and treated quickly.

Macon County Public Health gave the following influenza vaccines:

- Total Regular Dose Flu Given Since 8/1/2023: 402
- Total High Dose Given Since 08/01/2023: 189
- Total Flu Give Since 8/1/2023: 591

Remaining Stock:

- Regular Flu Vaccine (In Stock): 509 [Includes State (26) and Private (483)]
- High Dose Vaccine (In Stock): 204 [Private only]

RSV Vaccination: Respiratory syncytial (sin-SISH-uhl) virus, or RSV, is a common respiratory virus that usually causes mild, cold-like symptoms. Most people recover in a week or two, but RSV can be serious. Infants and older adults are more likely to develop severe RSV and need hospitalization. Vaccines are available to protect older adults from severe RSV. Monoclonal antibody products are available to protect infants and young children from severe RSV.

CDC Recommendations for Vaccination:

Adults aged 60 years and older

Adults aged 60 years and older may receive a single dose of RSV vaccine using shared clinical decision-making.

 Data to date suggest that vaccination uptake among adults and children this season is down compared to last season.

Pregnant people flu coverage is lower based on 1/13/24 numbers. Coverage at the end of 12/23 was 39% and currently 36% - down 3%. At end of 2021 coverage was 42% and currently 36% so 6% lower now, and in 2020 was 53% and currently 36% so down 17%.

In children overall flu vaccine rate is 47%. This is down 3% compared to same time during 12/22 and down 9% from 1/20 when the rate was 50% before the Covid pandemic.

Coverage decreases with age in kids. The lowest percent of vaccines is in ages 12-17 (41%), ages 5-17 (45%), and 6-23mo (60%).

Adult rate is 47% nationally which is similar to last year. Lowest age range is 18-29 (32%).

Age 75 and up are 80% vaccinated overall.

Antivirals

CDC recommends the following:

- If available Tamiflu or generic can be used to treat outpatients and hospitalized patients with flu.
- Oral baloxavir, inhaled zanamivir, intravenous peramivir can be used for early treatment of outpatients at increased risk for complications who present with uncomplicated flu, depending on age and contraindications.
- When there is limited availability of osteltamivir or other antivirals
 - Treatment should target patients with flu who are at highest risk for severe disease and those who are hospitalized
 - Treatment of outpatients should be prioritized for persons who test positive for flu within 2 days of illness onset
 - Patients with clinically mild flu who are otherwise healthy and not at increased risk of flu complications can be managed with supportive care without antiviral treatment.

Dr. Roy Lenzo asked about the current Covid death rate. Ms. Garrett replied it was not on the dashboard. Dr. Lenzo said he feels the current perception of Covid is that no one feels the need to get the vaccine. He added that if current data was available people might feel persuaded. Ms. Garrett agreed and added she was unable to find information about RSV deaths from the dashboard as well.

Dr. Matt Corbin asked if the immunization of flu vaccine was down in comparison to the last couple of years or pre-pandemic. Ms. Garrett answered pre-pandemic citing data in the above report. She said we have bought flu vaccine for several years and end up sending it back or to another health department. Ms. Enloe mentioned the flu vaccine is readily available in multiple locations. Ms. McGaha added that we have been seeing the decline locally and the national average is going down.

Dr. Corbin asked if there had been a decrease in prophylactic vaccines for infants and children outside of respiratory illnesses. Ms. Garrett explained Dr. Sears vaccine schedule and some people are choosing to follow it. She noted once children are school age they are required to have them, unless religiously exempt.

Garrett Higdon asked about Macon County immunization rates and how we compare with the national average. Ms. Garrett said she did not have that information with her, but she would be happy to send that information to the board. Ms. McGaha added that she did not feel we were doing as well as in the past. She contributes that to the overall decrease in desire to have children vaccinated since the pandemic. Adding that we may see an increase overtime in the next few years. Ms. Garrett agreed mentioning the return of childhood diseases like polio.

Ms. McGaha thanked Ms. Setzer and her staff for doing an excellent job with finances.
