Child Fatality Report Jennifer Garrett, Nursing Director gave the Child Fatality Report. She discussed causes and hos to prevent it. She is part of a large group of people that review this. They make recommendations and send to the state. A report is sent to the County Commissioners. Parents have to travel to Asheville. All of the 2020 reports have been handed in. She's now working on 2021 and reviewing 2022 cases. They have paid for Darlene Debty to be cars eat certified. We have bought car seats and give them to those that qualify. We partner with safe kids to do projects, some hot house projects. We have also bought some pack and play for parents that qualify. There have been some SID's deaths over the last couple of years. Dr. Carlos Vargas talked about reviewing the outcomes from the cases. Jennifer said they talk about what happened and how to prevent it from happening again. # Macon County Child Fatality Task Force 2022 Report

Macon County Commissioners and Macon County Board of Health I. Introduction

In 1993, the North Carolina General Assembly established a network of local Child Fatality Prevention Teams (CFPT's) across the state to confidentially review medical examiner reports, death certificates and other records of deceased residents under age 18. Each local team consists of representatives of public and nonpublic agencies in the community such as law enforcement, Guardian Ad Litem, health departments, among others, that provide services to children and their families.

The purpose of this report is to give a summary of the causes of death, the number of cases reviewed, recommendations for prevention, if any, that have been made and to share local team activities and accomplishments.

- II. Role of the MACON County Commissioners and Board of Health
  - Receive annual reports which contain recommendations and advocate for system improvements and needed resources, if requested.
  - Appoint members of the local team as identified by the membership.
- III. Child Deaths by Cause, System Problems Identified, Recommendations for Prevention & Proposed Action

In 2021, the Macon County CFPT reviewed <u>5</u> child deaths and identified <u>5</u> system problems and recommendations for future prevention efforts. Below are highlights:

#### Approval of Previous Meeting Minutes:

**ng** Mitchell Bishop made a motion to accept the previous minutes. Paul Higdon seconded the motion. Motion passed unanimously.

### **Old Business:**

Jimmy Villiard, Population Health Section Administrator, gave an update on the new Child **Molar Roller Purchase Update** Dental Unit project (Molar Roller). On May 1, 2022, the Request for Proposals for a new Dental trailer was released to the public for bid. The bid proposals were due NLT May 31, 2023. They received 4 bids ranging from \$646,900 to \$994,769. The lowest bid did not meet the requirements in the Request for Proposals. Bid proposals were reviewed by health department staff to include Child Dental staff, and on June 28<sup>th</sup> a recommendation was presented to the Board of Commissioners to accept the bid submitted by LifeLine Mobile. The Macon County Board of Commissioners voted 5-0 to award the contract to LifeLine Mobile for \$700,419. As of this afternoon, July 25, 2023, the contract has been signed by the County Manager. The new Molar Roller should be built and completed within 18-24 months. Jimmy also formally thanked Melissa Setzer for all her hard work on the project. Melissa talked about the budget for the Molar Roller and Medicaid Cost Settlement funds received to help offset the cost to the county for the new unit. She also discussed the possibility of maybe getting \$50,000 for the old Molar Roller according to estimates provided by LifeLine Mobile.

**FY24 Budget** Melissa Setzer, Finance Director, presented and explained the final FY24 Budget that was approved in June by the Macon County Commissioners. (Handouts of the Expenses and Revenues for FY24 were presented to the board.) Mrs. Setzer explained that the Health Department stayed flat for FY24 with the exceptions of budgeting for the new mobile dental unit and the department losing a couple COVID Agreement Addenda's.

### **New Business:**

### FY24 Fee Plan

Approval Melissa Setzer, Finance Director presented the most current Macon County Public Health Fee Schedule to the board. (Handouts were presented to the board) Mrs. Setzer explained that fees have been updated over the last six months using the methodology that is presented in the billing guide and was approved by the Board of Health and the County Commissioners. Normally, the fee plan is only presented annually in the beginning of the new fiscal year. As stated all fees are current and are adjusted based on cost of test, vaccines, supplies fluctuate during the year. The only fees that are not included in this fee plan are the Flu Vaccine fees. The cost of those vaccines will not be available until late August or early September. Once those cost are in, those vaccines will be calculated using the methodology approved as an attachment to the billing guide. The board was informed that a vote would be needed to approve the fee pan.

Mitchell Bishop made a motion to approve the FY24 Fee Plan as presented. Dr. Charles Vargas seconded the motion. Motion passed unanimously.

**FY24 Billing Guide** Melissa Setzer, Finance Director presented the FY24 Billing Guide. Mrs. Setzer presented the Billing Guide to the board and explained that the only things that has been revised in this guide is verbiage and two attachments added. Due to program monitoring over the last couple of months, the state consultants have advised the department of new verbiage that is required in the Billing Guides. Mrs. Setzer stated that changes highlighted in yellow were recommendations from the state representatives and all verbiage in red are new required verbiage based on new Title X changes. The bases of the new verbiage is to insure that all patients across the board either covered by private insurance, Medicaid, Medicare, or patient pay are all treated equally and have the same opportunities. Two attachments added to the Billing Guide include the patient waiver request form and the response letter to the patient.

Mitchell Bishop made a motion to approve the MCPH FY24 Billing Guide. Dr. Charles Vargas seconded the motion. Motion passed unanimously.
