Other Items for Discussion	Other Items for Discussion: O Kathy McGaha reported that one proposed budget cut by Governor Perdue is to adult Medicaid dental benefits. Ms McGaha said the proposal is to limit Medicaid reimbursement to emergency dental services only. It would not cover cleanings, fillings, or restorative procedures. Ms. Crawford stated that she is greatly concerned about this and that the committee members needed to stay aware of this issue. O The committee members also discussed commitments of the elderly; specifically by family members. The committee members further discussed this topic and agreed that offering training on elder issues to magistrates would be beneficial. O Rhonda Blanton informed the committee members that Michael Rich had resigned from the 30th Alliance. Mr. Rich will be the Director of Extension Education – Plus 50 Programs at Southwestern Community College. Mr. Rich offered to attend a future meeting and discuss possible collaborative efforts. O Rhonda Blanton passed out a handout titled – Workshop: Redesign home for elderly years. Ms. Blanton said this workshop had recently been held at Pardee Hospital on April 29th. The committee members discussed possibly hosting a similar event in Macon County.
