Other Items for Discussion	Other Items for Discussion were: Vanessa Bailey had got information from Rick Westerman on obtaining property for emergency housing. Ms. Bailey said he hoped to close on 14 acres of property on February 19 th . The facilities on that property will house up to 80 people. It will be a multi-use facility with a full-service kitchen. Jim Bottomley updated the committee members on the current status of the Samuel's House. This organization is still looking for property in Clay County. Mr. Bottomley said the Samuel's House representative will be speaking to the Zonta Club soon. Jennifer Turner-Lynn is replacing Bob Scott on this committee. Ms. Turner-Lynn is hoping to do an in-depth survey of the older population (over 65) in Macon County. Ms. McGaha suggested using the upcoming Senior Expo and Health Fair as a location to gather this information. Rebecca Barboff asked the committee members to consider the plight of the older teenagers (16-21) transitioning out of care into adulthood. Once they transition out, they must become totally self sufficient and learn to live and survive on their own. Jennifer Garrett explained that Dr. Vargas is starting the Tar Wars program back up in the local schools. Ms. Garrett said the program will be done in the fourth and fifth grades.
