Notice of General Election Macon County North Carolina 2022

A General Election will be held in Macon County Tuesday, November 8, 2022 to vote in the following contests: Commissioner District 1, Commissioners District 2, Register of Deeds, Clerk of Court, Sheriff, School Board District #2, School Board District #4, Soil & Water Conservation, NC House of Representatives District 120, District Attorney District #43, etc.

The polls will be open Election Day from 6:30am-7:30pm. All polling locations in Macon County will be open on Election Day. Curbside voting is available for voters who are unable to physically enter the polling location. There will be NO voting at the Macon County Courthouse on Election Day, you must go to your polling location to vote. If you do not know your polling location, please contact the Board of Elections office and they can assist you with that information.

All voters may participate in the General Election. If you are not registered to vote, you may register at the Board of Elections office, located in the basement of the Macon County Courthouse, or contact the office and one can be mailed to you, or you may go to the website, maconnc.org, and print one, fill it out and mail it in to the office. The voter registration deadline is Friday, October 14, 2022 at 5:00pm. If you miss this deadline you can register to vote, and vote in the same day during early voting with the proper documents.

<u>Early voting will begin on Thursday, October 20, 2022 thru Saturday, November 5, 2022.</u> There will be 2 locations for early voting:

<u>The hours for both locations will be Monday-Friday from 8:00am-7:30pm and Saturdays from 8:00-3:00pm.</u> Saturday, November 5, 2022 at 3:00pm early voting will end. <u>Early voting always ends on the Saturday before an Election.</u>

Absentee Voting by mail will begin on September 9, 2022 and will end on November 1, 2022 at 5:00pm. Any voter can submit a completed, required State Absentee request form and your Election ballot and instructions will be mailed to you. The required State Absentee request form can be found on the Macon County Board of Elections website under the voting tab. You may also contact the Board of Elections office 828-349-2034 and one can be mailed to you,

Absentee meetings will be held in the Board of Elections office on October 4th, October 11th, October 18th, October 25th, and November 1st. There will be an Absentee ballot meeting on Monday, November 7th. Absentee ballots and One Stop early voting ballots will be approved on Tuesday, November 7, 2022 at 5:00. NO results will be made public until 7:30pm. Results will be located on the BOE website or the ncsbe.gov website under "scrolling election results".

<u>Canvass</u> meeting will be held on Friday, November 18, 2022 at 11:00am. Canvass is a meeting in which Provisional ballots are counted and the Election results are made official.
