The **STANDARD BID FORM** is included in the bid package for your use. Only this bid form is to be used. Any other bid form will be disregarded. Please indicate your firm's name on the Bid Form and have it signed by a person authorized to do so. Complete the Standard Bid Form in full and attach all required forms in accordance with the instructions within the bid form.

It is understood and agreed that your bid is for this project as specified or as amended. The Owner reserves the right to determine the acceptability of any proposed or alternate substitutions.

You and/or your firm must be a licensed general contractor, in good standing, in the State of North Carolina.

This solicitation does not commit the County/Airport to award a contract, to pay any costs incurred in the preparation of the response to this solicitation or to procure any goods or services.

The contract will be awarded to the lowest responsible, responsive bidder, taking into consideration quality, performance and the time specified in the bids for the performance of the contract. Bids are not subject to public inspection until the contract has been awarded.

IN THE EVENT OF DEFAULT BY THE SUCCESSFUL BIDDER, THE COUNTY RESERVES THE RIGHT TO PURCHASE THE ITEM/S IN THE OPEN MARKET AND CHARGE THE DEFAULTING SUPPLIER FOR THE DIFFERENCE/S IN COST/S. SHOULD SUCH CHARGE BE ASSESSED, NO SUBSEQUENT BIDS FROM THE DEFAULTING SUPPLIER WILL BE CONSIDERED UNTIL THE ASSESSED CHARGES ARE SATISFIED.

The County/Airport reserves the right to examine the financial responsibility of any or all bidders to determine what assurance we may have of obtaining subsequent services on this project after completion.

Respondents must clearly mark as "Confidential" each part of their bid, which they consider to be proprietary information. Pricing will NOT be considered "Confidential".

E-Verify is the federal E-Verify program operated by the United States Department of Homeland Security used to verify the work authorization of newly hired employees pursuant to federal law. Article 2, Chapter 64 of the North Carolina General Statutes requires that all employers doing business in the state of North Carolina, who employ 25 or more employees in this State, use E-verify to verify the work status of newly hired employees. North Carolina General Statute 153A-449, as amended, states "No county may enter into

a contract unless the contractor and the contractor's subcontractors comply with the requirements of Article 2 of Chapter 64 of the General Statutes." Therefore any contractor who employs 25 or more employees, or who engages a subcontractor who employs 25 or more employees, and enters into a contract with the County, must comply with N.C.G.S. § 64-25, et seq. The contractor and/or vendor acknowledges that payment by the County is conditioned upon the contractor's, or its subcontractor's, compliance with Section 2 of Chapter 64. Failure to comply may render any contract with the County void and unenforceable.

The Board of County Commissioners/Airport Authority Board reserves the right to cancel in whole or in part any solicitation when it is in the best interest of the County/Airport. The Board of County Commissioners/Airport Authority Board reserves the right to reject any or all bids or portions of bids and to waive any informalities or technicalities in bidding so as to purchase in the best interest of the County/Airport. Responsibility of the bidder or offerer shall be ascertained for each contract awarded by the County/Airport based upon full disclosure to the County/Airport concerning capacity to meet the terms of the contracts and based upon past record of performance for similar contracts.

Scope of work:

Replacement of an approximately 12,000 sq. ft. roof on the Macon County Airport Meeting Room (old terminal building).

- Remove existing metal roofing, skylight panels, insulation, pipe boot flashing and sealants on entire building.
- Install new insulation over newly remodeled area approximately 1,200 sq. ft.
- Install new bottom edge trim to cap insulation.
- Install 24 gauge/3' wide/PBR profile panel/glare resistant metal/exposed fastener metal roofing system over entire hangar.
- Install new skylight panels, pipe boot flashing, exterior trims, sealants and ridge cap.
- Clean up all debris. Haul debris to an approved recycling facility or landfill.

This shall include premises and/or operations, independent contractors, products and/or completed operations, broad form property damage and explosion, collapse and underground damage coverage, sudden and accidental pollution losses, and a contractual liability endorsement.
- Workers Compensation: Coverage to apply for all employees for statutory limits in compliance with the applicable state and federal laws. The policy must include employer's liability with a limit of \$100,000 for each accident, \$100,000 bodily injury by disease each employee and \$500,000 bodily injury by disease policy limit.
