Update on Well Program	<ul> <li>Barry Patterson updated the task force members on the Well Program. Mr. Patterson reminded the task force members the Well Program started on July 1<sup>st</sup> and has been proceeding very well.</li> <li>Mr. Patterson stated there are two full-time well specialists and currently four additional Environmental Health staff who have been cross-trained for the Well Program. Mr. Patterson said the fee for a permit to construct a well is \$375. He stated that the fee to repair a well recently increased from \$80 to \$125.</li> </ul>		
	Mr. Patterson said the majority of well permits are being processed in four working days. Mr. Patterson said one idea being considered is to offer a discount fee if both septic and well permits are applied for at the same time.		
Public Education	<ul> <li>Barry Patterson led a group discussion on public education:</li> <li>Mr. Patterson said a trial mailing was sent to a small listing of members from this task force plus a few other selected names. Mr. Patterson asked for feedback from the task force members that had received the sample mailing.</li> <li>Kathy McGaha (who received the sample mailing) made the following suggestions:</li> <li>Add www. to website information</li> <li>List actual signs of a septic system failure</li> </ul>
