**GENERAL DEFINITION OF WORK:** Duties include promotion of public health through education, surveillance, consultation, inspection, and enforcement of state and local environmental health laws and regulations. The majority of work will be in the On-site Waste Water and Private Drinking Water Well programs, including evaluation of sites for well-water systems, layout of systems, inspection of systems for proper installation, investigation of general environmental health complaints, and evaluation of problems with existing systems. Some work may include inspection of food handling establishments, hotel, motel and other lodging establishments, public swimming pools, daycare centers and, migrant housing to determine compliance with current sanitation standards.

• Ability to analyze and comprehend a wide variety of technical and administrative regulations, records, and reports.

• Ability to exercise sound judgment and deal tactfully with a wide range of public contracts while enforcing public health laws and regulations.

• Ability to motivate and educate business and property owners and the consuming public in matters related to protecting and promoting public health.
